Aaron Hood made the motion to attain a line of credit through Trustmark Bank. Don Mack seconded the motion, all approved.


Don Mack made the motion to require employees to pay 25% of their health insurance starting December 1, 25. Dianne Epperson seconded the motion, all approved.

Mayor Cooner opened the meeting for public comments.


Katie Cheslock gave an update on Centreville Main Street.

Jeff Lawrence came asking to be disannexed from City of Centreville because of water situation. Council will discuss and get back to him.


Don Mack made a motion to adjourn the meeting. Aaron Hood seconded, all approved.








