Aaron Hood made a motion to approve joining the SSUT litigation with the County. Linda Lawrence seconded the motion. All approved and motion carried.


Aaron Hood made a motion to delay the Insurance deduction from Dec '25 to Jan '26. Don Mack seconded. All approved and motion carried.


Aaron Hood made a motion to reinstate the Food Truck Ordinance. Don Mack seconded. All approved and motion carried.


Mayor Cooner declared a Work Session prior to the Jan 6, 2026 meeting at 4pm. This will include all department heads.


Don Mack made a motion to adjourn the meeting. Dianne Epperson seconded. All approved and the motion carried.


