REGULAR MEETING

The City Council of the City of Centreville met in a regularly scheduled meeting on Tuesday evening, Mar 17, 2026, in the Centreville City Hall at 5:00 P.M., regular place and time for holding said meeting.

Mayor Barry Cooner called meeting to order at 5:00 pm, followed by invocation and Pledge of Allegiance.

Mayor Cooner declared a quorum present and meeting was open for business.


Katie Cheslock and Ashton Cottingham updated on Centreville Main Street projects.


Public Comment:


Motion to adjourn the meeting. All approved. Motion carried.
